New Funder Supports Jefferson County Residents

Circle of Concern has supported the Fenton community, which straddles both St. Louis and Jefferson counties, for many years. In 2023, we expanded further into Jefferson County, adding the High Ridge community to our service area.

Now, Jefferson Foundation is supporting this effort. A grant award of \$10,000 is helping us to provide fresh foods and financial assistance to eligible clients. With these monies we have helped Fenton and High Ridge families with nutrient-dense fresh foods (protein and dairy items; and fresh fruits and vegetables); and also emergency rent and utility assistance.

Jefferson Foundation was created in January 2013, funded by proceeds from the sale of Jefferson Regional Medical Center in Crystal City. The Foundation's mission is to support charitable and educational activities promoting individual and community health and well-being in Jefferson County.

Take the Credit

The Missouri Food Pantry Tax Credit Program is a win-win for you *and* the families you help to feed! When you donate \$200 or more to Circle of Concern Food Pantry, we'll proactively send you a completed Missouri Food Pantry Tax Credit Form late in January to submit with your Missouri Income Tax Return. You'll receive back 50% of your donation in the form of a credit – up to \$2,500 (for a \$5,000 donation) for individuals and businesses; and up to \$5,000 for married couples filing jointly (for a donation up to \$10,000).
